In a discussion the following key points were raised;

- Recommendation of a focus on creating opportunities for nature in new developments: ensuring standards are enhanced where possible, connectivity of habitats is achieved, and the potential of green and open spaces in new built areas is maximised wherever possible. Examples given are opportunities for hedgehog highways; playgrounds and play parks.
- The County Council's method of asking open questions, asking people what they want, rather than presenting detailed information was questioned; more detailed information is expected to which consultees can then respond to, considering the County Council's in-house expertise and their responsibility to ensure that a strategy is joined up across a wide area.

It was proposed by Cllr Bros Sabria, seconded by Cllr Owen and **RESOLVED**, with 4 voting for and 2 abstaining, **for the clerk to submit a response to this consultation including the above points raised.**
