Faith Land (CG)

- Bidding window launched.
- Further Faith Strategy Group meeting, representatives from all active faiths in Northstowe seeking representation, currently listed below:
 - Buddhist
 - Cambridge Alliance Church
 - Northstowe Muslims
 - o Hindu Samaj Northstowe
 - Jain Community
 - Reformed Jewish Community in Cambridge, although they have now stepped back from interest.
 - Northstowe Church Network led by Pathfinder Church, alliance between the Church of England and various other Christian denominations.
 - o Emmanuel Church, Baptist aligned Christian denomination.
- As this is quite a list of interested communities, there will be likely disappointed groups, noting this, there's 3 future site allocations in Northstowe after this Phase 1 allocation.
 - o Phase 2 1000-1050sqm floor space
 - o Phase 3A 0.15hectares adjacent to local centre
 - o Phase 3B similar size to 3A adjacent to local centre/primary school.
- Opportunities around joint bids are welcomed, Church of England and various other Christian denominations are forming in effect a consortium.

Community Gym & Café

(CG)

- Community Gym Window for tenders has closed, a healthy number of bidders, scoring underway at the moment an aim to make an appointment in April.
- Decision made to take Café out of the operating contract. Meridian Trust and the school are in discussion with Northstowe Hub to operate the Café on a community basis, similarly to The Cabin – update at the community forum next week.

Update on Community Buildings/Construction (KD/MW)

• P1 Community Centre – Unity Centre

(KD)

- Unity Centre in Phase 1 is now under construction, proposed end date early 2026, programme on track.
- Road surfacing works ongoing around Pathfinder Way, Links Lane and Stirling Road.
- o Groundbreaking event, Cllr Henry Batchelor and local members to mark the fact the build is beginning. Future on-site opportunities during the process.
- Relocation of trees aim was to retain trees, due to the roots being entangled, there was risk of losing some, so 3 new trees have been provided.
- Blue hoarding will be fixed. Aware post and rail fence is damaged, meeting a contractor regarding this also, awaiting quotes.

P2 Town Hub / Cricket Pavilion

(KD)

- Atkins Realis feasibility study completed based on Section 106 reviewing benchmarks as to whether this still meets the needs as it was originally signed in 2017.
- Working with colleagues across County Council, Health, Libraries, Homes England and others who are specifically named and allocated space within the Town Hub.

Cricket Pavillion:

- o Discussion on going around land transfer.
- Identifying services, planning status, building start date, future governance etc working with Homes England
- o Runs alongside the latter half of the Town Hub construction, projected 2029.
