Hello everybody

As promised here is an update on the project. It is later than I hoped as I have been embroiled in deadlines for council business planning.

Work on the detailed design is well underway and we have a key milestone of a completed final design and the placement of the order for construction just before Christmas. It's extremely tight but is achievable. Factory time for the modules has been booked for January onwards. Based on this, further milestones are:

- + on-site works commencing mid-February
- + delivery of modules to site mid-April
- + building complete late May
- + ready to open late June

Obviously it all hinges on hitting the pre-Christmas deadline, and we are providing weekly updates to National Highways/Highways England to assure them of our progress. It does however mean that all our focus is on the final technical design process rather than other matters.

Additionally, Emma has arranged to visit Hilary to look at the LDHS collections in January, which will give us a better idea of what support is needed.

Therefore I am going to cancel the meeting next week as I don't have anything else to report other than the above about the building itself. I will keep you updated as we go along but I suggest we arrange to meet in the New Year. Please can you advise of your availabilities for:

- 10 January
- 13 January
- 14 January

Starting at the preferred time of 9-15am.
