#### Climate Action Conference

Last month I reported that SCDC was hosting a Climate Action Conference in Cottenham in November, coinciding with COP28, celebrating net zero action locally. I didn't make it to this myself, but the feedback is that it was well received by the 80+ people who attended. I don't know if anyone from the LPC, OPC or NTC attended, but for anyone interested, especially local environmental action groups, this video is a 4 minute overview of some of the innovative initiatives SCDC is supporting including Repair Cafes and Active Travel: https://www.youtube.com/watch?v=wE6EOhzwVmo

The Zero Carbon Communities grants have provided over £500,000 in funding locally since it was launched four years ago. Designed to equip community groups to take climate action at a local level, the grants have helped upgrade community buildings, educate people about their carbon footprint, and help nature recover in the district. The conference was so well received that I suspect it will be repeated with different but related content in the future.

# 4-day week and the government's Best Value Notice

There was an extraordinary council meeting about the 4-Day week held at SCDC on 20<sup>th</sup> November. I couldn't attend in person as I was still Covid positive. However, I did attend online on the Teams link. A decision was made to provide the Government with the data required by them to assess the trial. #### Homes for Ukraine: Appeal for support with Landlord Incentive scheme

In a previous report, you may remember that I drew your attention to a new scheme - the 'Homes for Ukraine Landlord Incentive Scheme'. In the scheme, landlords who provide properties in South Cambridgeshire to Homes for Ukraine guests and who are resident in South Cambridgeshire qualify for a financial incentive. These incentives differ depending on the size of the property, and whether they are provided at market rent or at the local housing allowance rate. Under the standard arrangements the landlord must provide a minimum tenancy of 6 months from the outset but if they offer 12 months initially, then they become eligible to receive double the amount for a 6-month tenancy. After the initial term expires, landlords can receive a further payment if they offer to renew the tenancy.

#### Continuation of 'thank you' payments for Homes for Ukraine Sponsors

We have been advised that the government is to extend for third year (nationally) the 'thank you' payments for Homes for Ukraine sponsors. The payments will remain at £500 per month to reflect the ongoing generosity of hosts in supporting those who have fled the war. A further £120 million is also being granted nationally to invest in homelessness prevention, which includes support for Ukrainian households who can no longer remain in sponsorship.

### Council's social housing maintenance

Just over a year ago SCDC entered into a completely new contract with Mears for the repair and maintenance of the council's social housing portfolio. A year on, a full contract review has been conducted. This shows that performance over the previous contract has improved significantly across the piece. There were, initially, some problems in a number of areas but Mears have put in additional measures to improve their performance, including operative upskilling and additional contractor support from central teams and subcontractors. Overall tenant satisfaction is high, with 93% of residents reporting satisfaction with the service they have received. Complaint numbers have been low and when they have been received, they have been fully investigated. The council will continue to monitor Mears' performance closely to try to drive standards higher still. # COUNCILS, RESPONSIBILITIES AND KEY GOVERNMENT FUNDED ORGANISATIONS

If you have a problem or concern do not worry too much about who can solve it just ask the question and we will endeavour to signpost to the right person. The organisational structure of Cambridgeshire is complex, but it is important to identify where responsibility lies.

### **County Council**

Responsibilities: Education, Transport, Highways, Heritage, Social care, Libraries, Trading standards, - Waste management, Maintaining their estate.

Some of these services are shared between Peterborough City Council and Cambridgeshire County Council but any concerns should be directed to the county council.

#### **District Council**

Responsibilities: Council tax payments and benefits, Household bin collections, Housing and housing benefits, Council leisure facilities, Environmental health, Residential planning.

#### Parish/ Town Council

Responsibilities: Looking after community buildings, Open spaces, Allotments, Play Areas, Bus shelters.

# Greater Cambridge Partnership (GCP)

'The local delivery body for a City Deal with central Government worth up to £500 million over 15 years, to vital improvements in infrastructure (decarbonising transport), supporting and accelerating the creation of 44,000 new jobs, 33,500 new homes and 420 additional apprenticeships.'
