Background	Cycle lanes are a key component of road design that encourage active travel, both for regular journeys, such as commuting to school or work, and for leisure or occasional use. In Northstowe, we currently have three main cycleways: one running alongside Stirling Road, another along Eagle Way and another one through Wellington Road. The cycleway on Stirling Road provides vital access to Northstowe Secondary College. However, a section of these cycle lanes remains incomplete. You may have noticed markings such as "Future" + Cycle sign on the surface of the cycle lanes. Unfortunately, permanent car parking continues to block these future cycle lanes, which prevents them from being used safely. Young people in Northstowe who cycle to school regularly are forced to repeatedly move on and off the lane into the road, especially during busy pick-up/drop-off rush hours. As reported by young people themselves, some students have even stopped cycling to school entirely due to safety concerns. Other residents and potential users may also wish to use the cycle lanes but feel discouraged because they do not perceive the routes as safe.
