Dear All

Since we met online to discuss the e-scooter expansion in your area we have been working with County Highways, Developers, Homes England, Smart Journeys, Teversham Parish Council and South Cambridgeshire District Council to firm up proposed parking hub locations. The map [here](#) shows the parking hub locations, and we would welcome any feedback.

We continue to work with Cambridgeshire County Council to agree parking hub locations in the Park and Rides, particularly Longstanton and New Market Road.

We have started to deploy, this week, a small number of e-bikes and e-scooters in the Teversham and Fulbourn area as discussions are advanced for parking hub locations. It is expected that this would be followed by Oakington and Longstanton, and then Northstowe. Babraham area, with a focus on the Research Campus will be the final area to receive e-scooters and e-bikes in this phase of the roll out.

It is hoped to have the roll out of phase 1 by mid-March where we will then monitor usage and act on any feedback received.
