

# CAMBRIDGESHIRE COUNTY COUNCIL REPORT – MARCH 2023

## LONGSTANTON, NORTHSTOWE, OVER, OAKINGTON & WESTWICK

#### FULL COUNCIL

##### Budget

Like three quarters of all councils in the country this year, Cambridgeshire County Council was forced to increase its portion of the council tax by 4.99 per cent, the maximum permitted.

As a Joint Administration we faced up to the financial challenge facing the county which results from a legacy of poor choices by the outgoing administration, along with the failure of the Government for a number of years now to introduce a fair funding formula. Without this, we receive a much worse deal than many other councils. Where we have had to make savings, we have done so carefully, and certainly not imposed the kind of savage cuts that some opposition councillors have mistakenly claimed.

##### Full Council meeting

The next meeting of the Full Council will take place on Tuesday 21 March. LibDems have submitted a motion for debate on the Government's decision to introduce new Voter ID requirements for elections. We are looking at ways the Council can support the effort to ensure the many people without the required photo ID apply for a free Voter Authority Certificate so that they are not denied their right to vote.

##### A14 Tree Disaster

After nearly a year of campaigning as LibDem Councillors and taking a motion to CCC full council, we have some development and good news:

The issue: National Highways have informed us that they planted 800k saplings along the A14 and 70% of which died, that is 560k trees!! National Highways had committed to replant the trees over 5 years, but they dragged their heels during planting seasons, it didn't go to plan.

The good news: Following our tireless campaigning they have reset the clock to start the 5 years of work again from Autumn 2023 and have committed to a new approach focussed on tree success rate rather than just number of trees planted.

#### CHILDREN AND YOUNG PEOPLE'S COMMITTEE

##### Great Gidding School

Councillors have agreed to move forward to the next stage of the statutory process which may result in the closure of Great Gidding CofE Primary School.

Cambridgeshire County Council's Children and Young People's Committee today (March 8) considered feedback received through the first period of public consultation on the viability of the school, where pupil numbers have been falling over recent years.

### Northstowe Education Campus

Cambridgeshire County Council's Children and Young People's Committee today (March 8) have approved: Round 2 of the Pseudo Dynamic Purchasing System (PDPS) to delegate responsibility for awarding and executing the contracts for the provision of early years and childcare starting April 2023 – April 2024 to the Director of Education. These are listed below.

- Early Years (EY) provision at the new primary school in Sawtry
- EY provision at the new primary school in Waterbeach
- **EY provision at second primary school in Northstowe Education Campus**
- EY provision at St John's Primary School, Huntingdon
- EY provision at Growing Places Children's Centre, Sutton

### Cambridgeshire Music

I have been appointed as a Board Member of Cambridgeshire Music based in Histon at Cambridgeshire County Council's Children and Young People's Committee today (March 8). Cambridgeshire Music is referred to as a partnership of school music providers, led by the County Council, to deliver the government's National Plan for School Music. I attended as a board member on Friday 3 March board meeting and look forward to working with the rest of the board to deliver its vision.

### Strikes in School

The National Education Union has announced four strike dates affecting Cambridgeshire.

- Wednesday 1 February (national) – which did take place
- Wednesday 1 March (East of England)
- **Wednesday 15 March (national)**
- **Thursday 16 March (national)**

The County Council's education team has been providing advice and information to schools, and the Director of Education has met with the Trade Unions. ## ENVIRONMENT & GREEN INVESTMENT

### Waste contract

The County Council's long-term waste disposal PFI contract with Thalia at Waterbeach continues to be a major preoccupation of the Council. Work is continuing on options for the odour emission abatement required by the Environment Agency, and Government changes to food waste collection arrangements are proving challenging.

### Swaffham Prior

There continues to be ongoing media interest in the Swaffham Prior renewable energy project, including from the BBC1 national morning magazine programme and the property section of the Sunday Times. The first homes in the village are already receiving heat from the new system.

### Waste water treatment plant

Anglian Water have withdrawn their application for the move of the waste water treatment plant from North East Cambridge to Horingsea, which we expect to be revised and resubmitted.

### Water industry consultation

Cambridge Water – Draft Water Resources Management Plan 2024 Consultation - closes 19 May.

## HIGHWAYS & TRANSPORT

### Local Highways Improvement Schemes

LHI bids being presented to councillors for recommendation to the Highways & Transport Committee will be considered at a panel meeting on Friday 12 May.

From now until 28 April, applications for new 20MPH speed limits can be submitted by any person as long as they have the support of their local parish or town council and county councillor. Once an application has been submitted it will be processed and prioritised, until all schemes have been delivered.

### Incident Reports

The Traffic Management Centre has responded to 138 incidents on the road network throughout Cambridgeshire in February covering 20 weekdays. This is a decrease to January but higher than that of February 2022. ## Meanwhile on the Combined Authority

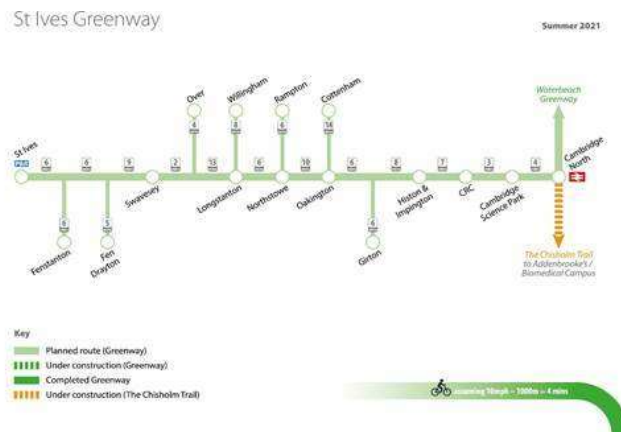
The Combined Authority Board continues to focus on its Improvement work. It has agreed to appoint an Executive Director Resources & Performance, and an Executive Director Economy & Growth.

## BUSWAY

### St Ives Greenway Project

Greater Cambridgeshire Partnership has been developing proposals for 12 new Greenways, which will provide safe, convenient, and attractive active travel routes between Cambridge and its surrounding villages.

The St Ives Greenway project is unique in that rather than create a new route, we aim to enhance the existing, well-used, active travel path parallel to the guided busway (also known as National Cycle Route 51) between St Ives and Cambridge. There are two elements to this. The first is to develop new connections to neighbouring villages so that people can more safely and easily reach the route by foot or cycle, and the second is to secure the longer-term resilience of the route to flooding between St Ives and Swavesey. See map below.



### Improving access to the Greenway

To bring benefits for communities along the route sooner, we are bringing two projects out to public consultation in February, these include a spur linking Oakington to Cottenham as well as spurs to Fen Drayton and Over. These spurs would provide safer and better connections for those walking, cycling and, where appropriate, horse-riding to and from the main active travel route.

On the 2<sup>nd</sup> of February, a briefing was hosted for the relevant ward and county councillors as well as the local Parish Councils for Fen Drayton, Over, Oakington, Westwick and Cottenham.

For both the Oakington to Cottenham spur and Over to Fen Drayton spur, there will be an eight-week public consultation via an **online survey** will run from **midday Monday 6th February** until **midday Friday 31st March 2023**. This will include an online public Microsoft Teams event, as well as materials being provided online for comment via a survey. ## LONGSTANTON

- Patching of the local roads below took place w/c 30 January, looks like there will be further patching on School Lane on 13 March from 8am to 4pm, <https://one.network/?GB133006170>
- The next phase will take place **beginning of June (weather permitting)** with the following treatments/dressings. Please refer to leaflets sent via email with February report.
  - B1050 Hattons Road (between Longstanton and Barhill) -Gripfibre treatment
  - B1050 Longstanton Bypass – Gripfibre treatment
  - School Lane - Surface dressing
  - Home Farm Road -Surface Dressing

Please note, all the below will be treated and assessed on a site-by-site basis in accordance with Cambridgeshire County Council's policy which can be found on the website:

- All junctions will be treated with the Gripfibre Dressing
  - All white lining replaced within 28 days
  - All studs/cats' eyes replacement
- New Farm Road drain covers are still on order, due to amount of drain covers stolen across the county CCC have been unable to source the covers as quickly as have hoped
  - Hatton Park Walking Bus is still in the making, as we have not had the required parent volunteers.

## NORTHSTOWE

- Transport Assessment & Smart Journeys  
The team are currently undertaking a review of Smart Journeys interventions in Northstowe including:
  - Revising the Monthly Ticket offer to residents to a Flex Ticket to reflect more flexible working practices.
  - Updating the E-cycle scheme.
  - Re-structuring the Electric Car offer to a more flexible scheme to encourage uptake
  - The team is also in discussion with Stagecoach and the developer to provide Bus Stop infrastructure for the existing (Citi 5) bus service to extend into Northstowe.
  - Longstanton Park and Ride Links – both links are now open. Balfour Beatty have confirmed the delivery of the lanterns for the streetlights is scheduled to arrive for March 9th and installations will take place very soon after. CCC Project manager has been on site and has identified minor snags only, a completion certificate will be signed following these works.
- Northstowe Resident Survey has now been published. [Cambridgeshire Insight – Housing & Planning – Housing priorities – New homes & communities](#). Please scroll down to and expand “The local picture”, and then scroll down to “New housing development surveys”. This survey took place between July and September 2022 and was posted to 1,095 households in Northstowe, with the paper survey containing the details of online access to the survey. Respondents could either complete and return the paper copy of the survey or complete the survey online. 384 responses were returned giving an overall response rate of 35%. As shown in the Table below, this response rate gives a level of statistical error at the 95% confidence interval of 4%, a common standard of error for this type of survey. This survey aims to find out about households in newer communities in order to assist in informing future planning decisions and service provisions for new developments.
- Thursday 9 March – virtual meeting was conducted with Pathfinder School, County Council education officers and Northstowe Town Councillors Cllrs Carla Bros and Cllr Majdi Mgaidia and Ellen Bridges from SCDC to discuss Early Years and Childcare in Northstowe. Next steps are to have an action plan in place and meet in 2 months.

- Air quality monitor on Station Road, Northstowe. SCDC Principial Officer for Environment Planning has confirmed that they had liaised with CCC in relation to the location of this equipment. The air quality equipment monitors the pollutants NOx, PM10 and PM2.5. The primary source of these pollutants is from road vehicles and SCDC are currently undertaking works to update their website and make this information publicly available. The area of Northstowe was selected, partly in line with the council's air quality strategy to monitor emerging development growth areas, but also through S106 funding secured by the council from the developers. The location is the best location to monitor air quality in Northstowe and it was chosen to be dependent on several factors such as land ownership, air flow around the equipment (pollen can give rise to adverse results) and being close to receptors.

## OAKINGTON

- 20mph and A14 Legacy - snagging works have now been shifted to 29 March and thereafter, a Road Safety Audit 3 (after completion) will take place.  
Oakington Primary School Head Teacher has reported that the new school signs are not visible and has written to Highways via the ReportIT tool to acquire a different sign. I have liaised with the project manager and confirmed to the Head Teacher that the signs have been placed on Water Lane, are the correct sizes for the V85 limit based on the traffic surveys.  
If a different sign is requested for the school, it would mean that discussions should take place with the Parish Council and it would need to be funded via a Private Funding Highways Improvement, details are on this link: [Privately Funding Highway Improvements - Cambridgeshire County Council](#)
- The double yellow lines on the junction have now been blacked out.

<p><b>District Council</b></p> <p>Responsibilities: Council tax payments and benefits, Household bin collections, Housing and housing benefits, Council leisure facilities, Environmental health, Residential planning.</p>
<p><b>Parish/ Town Council</b></p> <p>Responsibilities: Looking after community buildings, Open spaces, Allotments, Play Areas, Bus shelters.</p>
<p><b>Greater Cambridge Partnership (GCP)</b></p> <p>'The local delivery body for a City Deal with central Government worth up to £500 million over 15 years, to vital improvements in infrastructure (decarbonising transport), supporting and accelerating the creation of 44,000 new jobs, 33,500 new homes and 420 additional apprenticeships.'</p> <p>Partnership between Cambridge City Council, Cambridgeshire County Council, South Cambridgeshire District Council, University of Cambridge.</p>
