Changes proposed, compared to the Civic Year schedule for '23-'24:

Change proposed	Reason
Full Council: No Full Council meeting to be held in April.	We already have a full programme that month with the Annual Town Meeting. With careful planning, items could be put onto March or May FC meetings instead.
Personnel Committee: Reduce committee meetings from every three months to every four months; but extend each meeting from 1.5 to 2 hrs.	There is normally not enough business to be discussed - no need to convene every quarter. Ther is always teh opportunity to call for an extraordinary meeting in case of urgent situations re: personnel scenarios. Extend each meeting from 1.5 hrs to 2 hrs, so that the meetings that we do hold can be longer where needed.
Finance & Governance Committee, followed by Planning Committee: To be moved from second Tuesday to third Tuesday of the month.	There is often little spare time to prepare the finance paperwork and associated online accounting and banking early on in the month, considering that invoices often come in just before when the summons needs to go out, and considering the follow-ups from Full Council meetings usually coinciding with the next round of meeting preparations. By having these two meetings one week before Full Council meetings items that are to be deferred to Full Council from either committee can then also be picked up again the next week at FC, rather than having a gap of two weeks. For planning consultations being received just after the Planning Committee summons has been sent out, these could potentially be put onto Full Council instead, in discussion with the committee Chair, or an extension asked for until after the next Planning Committee meeting, as is being done now in most such cases.
