CHILDREN AND YOUNG PEOPLE

Ofsted report published

Cambridgeshire County Council's children's services have been graded overall as 'requires improvement' according to Ofsted—no change from the previous inspection. The report follows a recent inspection.

Inspectors said: "Senior leaders have now made an accurate self-assessment and have created strong foundations to drive practice improvement." However, inspectors said that although since 2019 there had

been no overall improvement in services for vulnerable children, they acknowledged that “evidence of concrete and significant improvement in recent months had taken place.”

They also added: “This improvement was initiated by a new chief executive and assisted by the appropriate decision to decouple shared leadership and service arrangements from Peterborough” and that “there has been significant political and corporate investment and commitment to the improvement of outcomes for children in Cambridgeshire.”

HAF Programme

The Holiday Activities and Food (HAF) programme is offering funded holiday scheme places for children in Cambridgeshire this summer who are eligible for free school meals.

This initiative by Cambridgeshire County Council offers primary and secondary school children in the county the chance to enjoy exciting experiences at a wide range of holiday schemes. With a focus on providing healthy meals alongside activities, the programme is ideal for children who want to stay healthy and active during the summer school holidays.

Any child receiving benefit-related free school meals is eligible for the programme, which will run between 23 July and 30 August. Approximately 19,000 HAF eligibility vouchers were sent to families on 10 June. Each voucher offers 64 hours of access, for no charge, to a HAF scheme during the summer holidays.

The programme will be delivered by approved providers, co-ordinated by Cambridgeshire County Council. The council is working with schools, childcare providers and voluntary and community organisations to deliver the programme.

As part of the programme, eligible children will be able to access:

- Fun and entertaining opportunities or new experiences that help children to develop their skills and knowledge
- A variety of holiday schemes including sports, playschemes, drama, technology, outdoor adventure and youth schemes
- At least one meal a day
- Guidance on increasing awareness of healthy eating, lifestyles, and positive behaviours
- Parents will be supported with information and signposting to other services and support which might be helpful to families

ENVIRONMENT & GREEN INVESTMENT

Wisbech incinerator

Before Parliament was dissolved at the end of May, the Government lifted its temporary ban on the Environment Agency issuing operating licences for new incinerators. The Environment Agency issued an operating licence for the Wisbech incinerator the same day. We continue to wait to hear what is happening to Fenland District Council's application for judicial review of the Government's decision to grant planning permission.

Envar incinerator in Woodhurst

The Planning Inspector's report on the appeal against the Council's refusal of this application has been sent to the Secretary of State for consideration. A decision is expected to be issued on or before 20 August 2024.

Deposit return scheme

Also before Parliament was dissolved, the Department for Environment, Food and Rural Affairs (Defra) confirmed that the Deposit Return Schemes for drinks containers will be introduced in October 2027, two years later than previously advised.

Controlling weeds

Cambridgeshire County Council chemical weed treatment programme has now begun, to address weed growth, which can be a safety hazard. This follows consultation with district, town, and parish councils across the county. Following consultation, a decision was taken to reintroduce planned chemical weed treatment twice a year, as a minimum, within built-up areas in villages and towns, inside the 40mph limit or below.

The weed treatment programme will commence in our ward on 24 June – Longstanton, Oakington & Westwick and Over and a second weed treatment programme will take place in October 2024.

Northstowe Busway Petition

Petition to Reinstate the Additional Morning Peak Hour Buses from Longstanton Park and Ride to Cambridge from September 2024 was launched on 2 June.

This came about after various reports on Facebook that these buses had stopped, when we were not informed locally that they had started again, considering we had a briefing from David Boden on 6 March!

Residents reported that the current buses arriving from Huntingdon/St Ives are often too full by the time they arrive at Longstanton Park and Ride, causing significant delays and leaving many stranded, waiting for two or three buses before we can board. This would obviously affect thereafter Oakington, Histon stops before many depart for either CRC or Cambridge Science Park.

I met with Stagecoach Managing Director – Darren Roe on 19 May with my County Councillor colleague Ros Hathorn (Histon, Impington & Orchard Park ward) Mr Roe stated that he would look into this issue. On 22 May, after follow up Mr Roe informed me that they are looking into September changes. On 24 May, I attended Longstanton Park & Ride when they were offering "Travel by Bus with a brew on us!" and spoke to the Stagecoach Operations Manager, Danny Smith in detail.

As reported in my April 2024 report, Cambridgeshire and Peterborough Combined Authority Board meeting papers for Bus Reform and Network Delivery update, it stated the following details for Longstanton ward are:

- 1, 17 (NEW) – Express via Busway, Cambridge to Huntingdon, Milton Road, Busway / Science Park, Busway / Histon & Impington, Longstanton P&R, Swavesey, Fenstanton. Largely limited stop catering for longer distance trips.
- 5 – busway A service additional Stops on Histon Road – this route could cater for Sixth Form Pupils attending Chesterton Road Sixth Form
- 7 (NEW) Longstanton Park & Ride to Sutton, rural linking villages to Busway and Sutton (for onward connections). This route could benefit for pupils attending Northstowe Sixth Form on the Education Campus due to open academic year September 2024
- 25 – Integrate Service 1A and 5A – St Ives to Bar Hill main points served will be Fenstanton, Fen Drayton, Over, Swavesey/Willingham, Longstanton P&R. Rural connections to main town and Busway.

Bringing the issue of Longstanton Park and Ride and the new proposals together, we decided as a Liberal Democrat group to start a petition to get these peak hour buses to be reinstated.

To date we have had over 100 responses with only one burst of marketing on local Facebook groups and following an email to the Combined Authority Mayor Nick Johnson on 2 June, we now have a meeting to discuss the above on 15 July.

Since the launch of petition, Ian Sollom was elected as MP on 5 July.

Anti-Social Behaviour across the ward

Working with CCC and SCDC officers and Police to find a solution to the ASB across the ward and beyond – specifically related to South Access Road West, B1050, A1307, Longstanton Road. A meeting was held on 5 June and updates were given by all and solutions discussed, action to invite Homes England to a meeting to discuss possible solutions as SARW is unadopted.

Oakington resident who lives close to Longstanton Road reported that the noise has reduced on 27 June. Longstanton PC chair reported that further reports were made recently, so not totally good news.

Northstowe Nursery on Education Campus

Following the tender process, Little Flames were awarded to run a full day care provision offering places for 9 months- to 4-year-olds. Having caught up with the owner on the 2 July, below are information acquired:

- To date over 60+ parents/carers have registered their interest in 3 days after announcement
- The National Insurance numbers are requested for Early Years funding purposes and are used for this purpose only
- All registrants will be emailed, via the Northstowe Nursery email account, thanking them for their submission and noting that further updates will be emailed directly to them over the coming weeks
- A copy of the company's GDPR Policy will be attached to these emails to confirm how they use and retain information gathered
- They are currently applying for their Ofsted registration, looking to open in September
- Do note that in the first term they will be sharing the nursery with the school, until the school is fully built in January
- They will open all year round, closed for 2 weeks off in August and 2 weeks at Christmas and all bank holidays
- They are looking forward to working with all the community groups for activities with the children and being part of our growing community, I will pass on details but we spoke about the great work that many of our groups are doing, allotments, sustainable Northstowe ...

LONGSTANTON

- Entrance to Northstowe Allotments: Met with drainage officer and planning officer on 19 June to discuss how we proceed with the works required on this section, as L&Q are delaying the works to join the pavements and closing the entrance. It was noted that there is a lack of drains on this section and work is commencing to see where new drains can be placed and the section of road damaged be resurfaced. No timelines available but Planning officer will pick up the works with L&Q to look to get some timelines for works to be completed.

NORTHSTOWE

- Travellers were reported on 4 July to be camping out on the corner of Stirling Road and Links Lane – where Hogs Roast use to trade from. L&Q reported that they came on site and found no one on site with caravans in the reported area and employment zone area.

- **OAKINGTON & WESTWICK**

Gas works from June to September, going ok, expected for reports that buses are not going through the village, working with CCC officers and Stagecoach to get the bus running through the village.

- Little Flames Childcare closed Oakington Pre-School in Easter 2024 because the low level of uptake and high costs was making it financially unsustainable.

Council officers considered what to do with the mobile building, which it leases from the Diocese of Ely and is subject to several restrictions on its use. Prior to Little Flames, another provider had operated the setting and had to close because of unsustainably low numbers. County Council Education Officers concluded that it was not practical to tender the building to other pre-school providers after two providers had been unable to sustain it, because of low numbers of pre-school-aged children in the local area and because there is alternative provision at Busy Bees Nursery School. Therefore, officers have concluded that the Council should withdraw from the lease and return the mobile classroom to the school for their use.

The Council's Strategic Assets Team is administering this process.

FIRE AUTHORITY New chief fire officer recommended

The Cambridgeshire and Peterborough Fire Authority Appointments Committee is recommending Matthew Warren as the new Chief Fire Officer/Chief Executive Officer for Cambridgeshire Fire and Rescue Service, following the retirement of Chris Strickland. Matthew is currently Deputy Chief Executive for Cambridgeshire Fire and Rescue Service and has worked for the Service for over twenty years.

Matthew joined in 2003 as Head of Finance, before becoming Director of Resources in 2009 and Deputy Chief Executive in 2015. He will be recommended to the full Fire Authority when it meets on Thursday 20 June.
