Background

This paper concerns the following road highlighted in red, which is frequently incorrectly labelled as Stirling Road on many maps:

Current uses of the road

At the west end of the road there is a light-controlled junction with the B1050 (Station Road) and Crabtree Road. At the east end of the road there is a T junction with Links Lane.

It also allows entrance to The Green, which is a paved, one-way, pedestrianised area with several parking spaces.


At the time of writing, the Unity Centre is being constructed at the corner of this road and The Green. The Unity Centre will have the address "1 The Green, Northstowe" reflecting the location of its main entrance. The Unity Centre also has multiple side accesses onto this road, including access to the garden.



Aside from the Unity Centre there are no other buildings on this road. The current impetus for naming it is to allow street finishing works to install final signage.

Potential future uses of the road

Prior design documents covering the Phase 1 "Local Centre and Enterprise Zone" show potential future uses of the area surrounding this road and suggest it could be pedestrianised with a replacement vehicular link provided to the north.



Potential future land uses in the vicinity.



Potential for future pedestrianisation with alternative route to B1050 provided to north.

"Vehicle access will be limited by closing off Stirling Road from Station Road. Speed will be limited in at entry points for cyclists and pedestrians, including opportunities for stopping-up and carriageway narrowing where appropriate and sensible." - Section 4. Mobility and Connectivity

It is unclear whether and when such a plan would come to fruition, but it makes sense for our naming recommendation to avoid options usually associated with vehicular traffic (eg, "Drive").

Nearby naming themes

- Crabtree Road is named after Crabtree Corner, an informal name for the B1050's curve at this point. This is part of the apple theme in phase 1 parcel H1.
- Stirling Road is named after the Short Stirling, a heavy bomber which was flown from RAF Oakington. This is part of the aircraft theme in phase 1.
- Links Lane is a reference to the Cambridge Golf Club. This is part of the golf theme in phase 1.
- Station Road refers to Longstanton railway station.

Recommended name

The following possibilities were put forward by councillors:

- Unity Drive / Lane / Road / Street / Way / Parade
- Green Street / Way
- Codlin, Pippin, Wallis or Hollendale Road / Way
- Pioneer Drive / Way / Lane / Street
- Unity Path / Crescent / Place / Way / Lane / Street
- Skyward Way / Lane

The Unity Centre itself was named after suggestions gathered from the public by SCDC Community officers in September and October 2024. Since the Unity Centre is an important and central feature of the road, it makes sense to carry this into the road's name.

Of the possible suffixes, Drive, Road and Street have vehicular connotations. Therefore, the recommendation is **Unity Way**, as Way is general enough to apply to potential future alterations to this road.
