Transfer from Longstanton Parish Council.

At the time of setting the budget, the amount to be transferred from Longstanton Parish Council was yet to be established. It is now thought it will be in the region of £30,000.00. This money will be held by Northstowe Town Council as a general reserve fund, and to support any budget line with £0.00 expenditure if required by the Town Council.

2020-2021 Expeniture

South Cambridgeshire District Council and the Northstowe Interim Council worked hard to ensure that the cost to residents in Northstowe was as minimal as it could be, whilst ensuring that the Northstowe Town Council had financial resources to establish the administration of the council.
