It was highlighted that the last time this application was considered (item 41/21-22(vi), committee meeting 11th January 2022), it was noted in the comments, as submitted, that there is limited toddler-friendly play equipment provided for in Northstowe Phase 1, although the Town Council acknowledged that the proposals were in line with the play strategy. It was proposed to support the revised application but that the previous Town Council comments still stand.

It was proposed by Cllr Littlemore, seconded by Cllr Benedicic and **RESOLVED unanimously that the** Town Council, with regards to planning application 21/05470/REM, wishes to provide the following comments: 'Northstowe Town Council supports this application, however our previous comments still stand in that finding play provision for toddlers within Phase 1 is difficult and would have preferred to have seen more traditional toddler friendly play equipment, although the Council acknowledges that this is in line with the overall Randall Thorpe Play Strategy.'
