Cllr Littlemore provided additional information, received through related discussions at the Northstowe Delivery Group and email correspondence, namely that L&Q has made it clear that they are progressing with the highway works and the legal agreements for highway adoption, and that neither parcel H5 (Bovis), where work has stopped, nor the delayed works at the SCDC-owned sites for the future Enterprise Zone, Permanent Community Centre and Local Centre should affect the timeline for delivery, and that any development subsequently permitted following road adoption would be subject to conditions regarding pre and post commencement highway condition surveys of the affected streets at part of a Construction Traffic Management Plan. Noted.
