It was proposed by ClIr Benedicic, seconded by ClIr Littlemore and **RESOLVED**, unanimously, **that regarding** application 24/04650/SCOP the Town Council wishes to submit the following consultation response: 'Northstowe Town Council wishes to object to the proposals in their current form. The Council questions the appropriateness of the proposed access route which is to cross the existing Wilson's Road bridleway, considering its current users including horse riders and the potential dangers that the access road may bring to bridleway users. In addition, the Council is concerned about the proposed deer fencing; considering the narrow strips of land alongside the parcels being proposed for the development could be home to deer, the fence may potentially lead to increased risks of collisions with vehicles using the Southern Access Road West. The Council recommends that adequate provision is provided for deer-sized animals to cross the development site. On a final note, the Council also wishes that the whole of Northstowe is to be considered for such solar farm developments and considers that hard surfaces such as car parking areas should be considered and which would have considerably less environmental impact than the current proposals.' *vii*) Consultation 24/04716/REM
