It was proposed by Cllr Littlemore, seconded by Cllr Benedicic and **RESOLVED**, unanimously, **that regarding application 25/00656/CL2PD the Town Council wishes to submit the following consultation response:**  
***'Northstowe Town Council warmly welcomes a retailer's interest in investing in Northstowe and recognises the positive impact this development could have on our growing community. In order to enhance the success of the project, the Council suggests reviewing the proposed number of car parking spaces to ensure it can accommodate customers and avoid additional strain on the B1050.***

***We also see an opportunity to explore an improved design for the site entrance, ideally one that aligns with the future Enterprise Zone entrance on the other side of the B1050, creating a more seamless junction and maximising benefits for all users.***

***Finally, the Council invites the applicant and prospective tenant to engage directly with Northstowe Town Council. By working together in an open and proactive dialogue, we can bring forward the best possible offering for both Northstowe and the retailer, ensuring the new retail site fully complements the broader development objectives for our town.'***

ii)	25/0109/TTCA Northstowe House Rampton Road Longstanton. Field Maple 1.1 - Remove failed and hung-up stem as well as the branch is it resting on to reduce the risk of failure onto bridleway. All cord to be cut to 0.5m and stacked neatly away from footpath in vegetation. Ash 1.2 - Remove primary branch overhanging footpath at approximately 8metres to reduce failure onto footpath. Remove deadwood >4cm diameter over footpath. All cord to be cut to 0.5m and stacked neatly away from footpath in vegetation. Ash 1.3 - Fell north-eastern stem growing over footpath back to twin-stemmed union to avoid failure of stem at the point of union. Pollard south-western stem over field to approximately 7 meters and at appropriate growth points. All cord to be cut to 0.5m and stacked neatly away from footpath in vegetation. Ash 1.4 - Fell 2x stems marked with red spray, in figure 7 below, due to poor form and to reduce the risk of failure over the footpath. - a) Greater Cambridge Shared Planning & Greater Cambridge Shared Waste – Consultation: Four-day Week survey (Best Value Duties) – Invited Organisations/Town and Parish Councils: (emails/information shared with Cllrs.).  
Deadline for consultation responses: 23<sup>rd</sup> March 2025.

It was proposed by Cllr Owen, seconded by Cllr Benedicic and **RESOLVED**, unanimously, **to submit a consultation response to the ‘Four-day Week survey (Best Value Duties)’ survey, including the clerk’s satisfaction levels, based on his experience of engagement with each of the SCDC departments to date, as discussed with the committee, together with the following general comments: ‘For the SCDC services where contact has been more than just occasional the general feeling is that there has been little if any change (either way) when comparing engagement before and after 1st of January 2023. It is, furthermore, clear that there are some officers in various departments who do not work 4 days/week despite being signed up for it, as their work seems to demand more time input.’**

- b) Cambridgeshire County Council - Care together. Input requested on Seed Funding for the final year of seed funding activity for the Care Together programme. (Email shared with Cllrs.). Deadline for consultation responses: 20<sup>th</sup> March 2025.

It was proposed by Cllr Littlemore, seconded by Cllr Owen and **RESOLVED**, with 4 voting for and 1 abstaining, **to not send in a consultation response.**

- c) 3C Shared Services – Naming of Street name ‘The Green’ for the New Community Centre. (Email shared with Cllrs.).  
Deadline for consultation responses: 24<sup>th</sup> March 2025.

It was proposed by Cllr Benedicic, seconded by Cllr Owen and **RESOLVED**, unanimously, **to submit the following consultation response and submit associated questions for clarification purposes: ‘As long as the address for the Unity Centre is going to look something like this, the Council does not see a problem with the street name ‘The Green’: “Unity Centre; The Green; Northstowe, Cambridge CB24 1FD”. Would the 3C Shared Services be**

able to clarify if this is the address as envisaged with this street name in place? If the plan for the address will look different, the Council would welcome an understanding how any confusion with 'The Green' as the name for the public square to the north of the road 'The Green' could be avoided. The Council wishes to also understand better if 'The Green' as street name is also going to be used for any other developments (besides the Unity Centre) that are facing The Green? Is 3C Shared Services able to clarify the plans for future developments? In this, the Council would welcome pragmatic examples of how address management is going to work as and when further shops, businesses, houses or flats are going to be built near and around the Unity Centre - would all of these also use 'The Green' as their street name, or would (some?) be given the existing street names of Stirling Road and Pathfinder Way, for instance.'
