Background	The Warm Hub has been running for the last few months, led by NTC and a number of community volunteers. This arrangement was due to conclude at the end of March when funding from CACRE stopped. CACRE had an underspend on the funding throughout these months and offered to continue the WH initiative funding until the end of May.
	A motion was presented at the last full town council meeting to pass on the leadership of the WH to a community group (Northstowe Hub). This motion was deferred and the council asked for further information and more options to be considered.
	 The Warm Hub Working Group met to discuss options available to the council with regards to continuation of the Warm Hub Meeting was held with trustees from Northstowe Hub Working Group came into consensus that continuation of service was paramount to the community Strain on existing volunteers was recognised as being the pain point Additional volunteers have come forward Cllr Benedicic happy to take ownership of WG and leading organisation for months of April & May
	This motion is presented to provide that additional information for the full town council to consider.
	This motion will cover the next two months of confirmed funding, should and further future funding become available additional information and motions will be provided to the town council for consideration.

Issues/items for The following options where considered: consideration by the Council 1. To organically allow the Warm Hub to cease operations 2. To continue operations led by NTC, changing Working Group leader to Cllr Benedicic 3. To pass ownership in full to Northstowe Hub The first option was felt to be of detriment to the community and as such should be ruled out. The second option was felt to be the best option for the short term. Since the full town council meeting where this was discussed a number of additional volunteers have stepped forward to help out. Existing arrangements with community groups are able to continue and provide volunteers and wrap around activities. Financial management of the grant funding will continue to be held with NTC. No additional paperwork is required with CACRE. The third option was discussed with Northstowe Hub trustees and it was felt that this was not within the spirit of what was originally discussed, the group is still in the process of forming their structure and as such are unable to manage funding and other financial aspects. Northstowe Hub are keen to work with NTC to help provide direction of what activities and events the community would like to have available to them. Northstowe Hub are willing to help with volunteers and other areas of involvement. Recommendations For the Town Council; 1. To receive update from Warm Hub WG on developments since last full council meeting 2. To approve the addition of Graeme Hodgson, Aparna Nigam, and Cllr Naveen Castelino to the Warm Hub Working Group 3. To approve the recommended option for management of the Warm Hub for the months of April & May, as outlined in the motion paper 4. To approve the renaming of Warm Hub to Northstowe Community Lounge The Warm Hub Working Group is recommending the 2nd listed option to the town council, this is to continue operations in the same format as has been running previously, with financial ownership held with NTC and with NTC leading the Warm Hub/Northstowe Community Lounge. Leadership of the Warm Hub Working Group will pass to Cllr Benedicic to manage for the months of April & May. Existing community groups (Northstowe Hub, Pathfinder Church, Emmanuel Church, Hindu

Samaj Northstowe, Northstowe Muslims etc) will continue to provide volunteers and activities.

Should further funding be available in future, a new motion would be presented to the town council with a more formal arrangement documented between NTC and the various community groups in the form of a MOU (Memorandum of Understanding).
