- 1. Stephen Kelly opening, planning policy update
 - a. Preparing preferred options in the autumn
 - b. Timetable takes out to 2024
 - c. North East Cambridge Area Action Plan
 - i. Seeking approval for document
 - ii. Needs to be paused while waiting for regulatory approval
 - iii. Again takes out timetable to 2024

 - c. District is attractive to both global investors and people that want to live in the area
 - d. Schemes such as Bourne, Waterbeach, Cambourne and Northstowe are trying to take most of the heavy lifting in building larger communities to reduce the pocketed development across the district.

 - f. Can we have visibility of whats happening between travel plans and housing/development plans?




Greater Cambridge Local Plan



- Preparing for Preferred Options consultation in the autumn
- Will respond to comments received through our First Conversation in early 2020, and issues arising from the December 2020 workshops considering our initial evidence and development strategy options.
- Will set out the preferred approach to the development strategy for Greater Cambridge.
- Will set out policy approaches that the plan could take, and sites that could be allocated for development.
- The consultation will be an opportunity to hear views on preferred approach and consider any changes before a full draft Local Plan is prepared for consultation next year.

Process of Local Plan preparation



North East Cambridge Area Action Plan



- · New Community Forum launched in March
- Currently considering the comments made in the consultation last year and preparing the next version of the Plan
- Committee cycle in October-December for Proposed Submission Plan.
- Publish representations and consultation statement alongside
- AAP process then paused until the Waste Water Treatment Plant Development Consent Order process is complete
- If approved, there will then be full public consultation on the Proposed Submission Plan

Timeline and Status

"We will seek to implement the Spatial Framework as spatially specific national planning policy. Local planning authorities preparing local development documents (including local plans) will have to have regard to the Spatial Framework, as they do with other national policies and guidance... We expect local planning authorities to continue to develop local plans before the publication of the Spatial Framework"
